I am enclosing my NON-REFUNDABLE payment of \$_____*, (payable to NEXUS Association of REALTORS) which includes the one-time \$60 application fee for the <u>2021</u> dues. However, I understand that in the event of non-election that only the dues dollars will be returned to me.

In the event of my election and as a condition of membership, I agree to abide by the Code of Ethics of the National Association of REALTORS[®] (NAR), which includes the duty to arbitrate, and remain in compliance with the continued mandatory ethics training as required by NAR[®]. I also agree to uphold the rulings of the Constitution, the Bylaws and the Rules and Regulations of NEXUS AOR, the New Jersey REALTORS[®] (NJR) and the National Association of REALTORS[®] (NAR).

I understand membership brings certain privileges and obligations that require compliance. Applicants who do not attend the orientation after 2 successive offerings will be dropped from membership and forfeit their application fee and must then reapply for membership and resubmit the application fee. I further understand that my membership is final only upon approval of the NEXUS AOR's Board of Directors and may be revoked should completion of requirements, such as orientation, not be completed within the timeframe established in NEXUS AOR Policies.

NOTE: The applicant acknowledges that if accepted as a member and he/she subsequently resigns from the Board or otherwise causes membership to terminate, while there is an ethics complaint pending, the Board of Directors may condition renewal of membership upon applicant's certification that he/she will submit to the pending ethics proceeding and will abide by the decision of the hearing panel. If the applicant resigns or otherwise causes membership to terminate, the duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided the dispute arose while the applicant was a REALTOR[®].

NEXUS Association of REALTORS® REALTOR® MEMBERSHIP QUALIFICATIONS AND POLICIES 2021 REALTOR® Application

REALTOR[®] membership in the NEXUS Association of REALTORS[®] (NEXUS AOR), New Jersey REALTORS[®] (NJR) and the National Association of REALTORS[®] (NAR) is a privilege provided to qualified licensees. The following document outlines the criteria for membership, policies that govern membership and the procedure for joining the organization.

Qualifications of Membership:

An applicant for REALTOR® membership will supply evidence satisfactory to the association, that:

- 1. He/she holds a valid NJ Real Estate license as a, Broker Salesperson, Salesperson, or Appraiser.
- 2. Salespersons or Broker Salespersons can only apply for membership if their sponsoring broker is a member and must make written application on a form acceptable to the association.
- 3. Within the past three (3) years has no violations of (1) civil rights laws, (2) real estate license laws, and (3) or other laws prohibiting unprofessional conduct against the applicant rendered by the courts or other lawful authorities.
- 4. He/she shall complete an orientation program on the Code of Ethics of not less than two (2) hours and thirty (30) minutes of instructional time within sixty (60) days of joining. This requirement does not apply to applicants for REALTOR[®] membership who have completed comparable orientation in another association, provided that REALTOR[®] membership has been continuous, or that any break in membership is for one (1) year or less.*

* Applicants who are <u>required</u> and do not attend the mandatory Orientation Program will be dropped from membership and forfeit their application fee and must then reapply for membership and resubmit the application fee.

Membership Policies:

The following are a few of the major policies of membership that all member applicants should be aware of:

- 1. The applicant agrees to abide by the Constitution and Bylaws and Rules and Regulations of the NEXUS AOR, NJR and NAR.
- 2. The applicant must submit a copy of their valid driver's license when applying for membership.
- 3. Members shall pay in advance the annual dues for the following year, the NEXUS AOR portion will be electronically billed in July and the NJR and NAR portions will be electronically billed in October of the current year.
- 4. Any payments due and received after the due dates will be subject to late charges.
- 5. Any member that is not paid in full by January 1st of the following year will be considered delinquent and will have their services terminated.
- 6. REALTOR[®] members who fail to pay their annual dues within the allotted time will be dropped from membership and will be required to re-apply and pay a reinstatement fee in order to be reinstated to full REALTOR[®] membership
- 7. A REALTOR[®] who changes the conditions under which he/she holds membership shall be required to provide written notification to the association within 30 days.
- 8. Every REALTOR[®] member of this association will abide by the Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS[®], including the duty to arbitrate controversies arising out of real estate transactions as specified by Article 17 of the Code of Ethics.
